GME Advocacy Coalition Supports the Resident Physician Shortage Reduction Act.

As part of the Graduate Medical Education (GME)
Advocacy Coalition, ASAM and 68 other organizations,
submitted a letter of support for the recently introduced
Resident Physician Shortage Reduction Act (S. 834), which
would gradually raise the number of Medicare-supported
GME positions by 2,000 per year for seven years, for a total
of 14,000 new slots.
